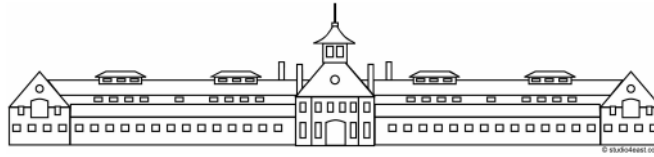

## Terms and Conditions

1. **The promoter reserves the right to accept or deny each application.**
2. Applicants will be notified of acceptance beginning May 1<sup>st</sup>. You will receive detailed Festival information prior to the Festival.
3. **The Festival will go on rain or shine.** This is an outdoor event. Vendors must have a substantial tent or canopy for themselves.
4. All participants must operate on Saturday from 10am-6pm, and Sunday from 11am-5pm.
5. Booth area includes stakes and ropes. Total booth area must not exceed those listed without permission prior to July 31, 2009. *Note changes this year.*
6. Food vendors must state all foods they wish to offer. We want to avoid duplication and have an interesting variety of food. Foods made with garlic will have a priority in our selection. Creative garlic foods are in great demand! People want garlic, garlic, garlic!
7. All Food vendors may sell water, soft drinks, coffee, and juices.
8. **All Food vendors** must provide a **Certificate of Insurance** with a liability limit of no less than \$1,000,000 and shall name Empire City Farms, Cuba NY Chamber of Commerce, and Cuba Garlic Festival as additional insured's.
9. Vendors requesting electric will be assigned one (1) 20 amp circuit. A \$15 fee will be charged for each additional 20 amps of service requested. Please note that Food Vendors will take priority when assigning electric circuits.
10. Food vendors will be issued four (4) non-transferable passes. All other vendors will be issued two (2) non-transferable passes per registration. Additional one-day passes may be purchased at the Check-In booth for \$2.00/day.
11. Set-up will take place Friday, September 18<sup>th</sup> from noon to 6:00 pm, and Saturday, September 19<sup>th</sup> from 7:00 to 9:00 am. *We encourage Friday set-up. **The grounds must be cleared by 6pm Friday.***
12. Booths must be completely set-up 1 hour prior to opening for booth inspection.
13. **NO** vendor or sponsor vehicles will be permitted on the grounds after 9am on Saturday, 10am on Sunday, with the exception of pre-approved handicap parking.
14. No tables and chairs will be provided. Please remember to bring your own.
15. Racks, signs, tables, chairs and displays may not extend more than 2 feet in front of your booth, and must not impede traffic flow.
16. Pets will not be permitted on the Festival grounds. This will be strictly enforced!
17. Your application must be postmarked by April 15, 2009 for the early reduced fee. **The final acceptance date is JULY 31, 2009.**
18. **Vendor fees are non-refundable.**
19. Each vendor will be responsible for his/her property. **Empire City Farms, Cuba NY Chamber of Commerce and/or The Cuba Garlic Festival, are not responsible for any damage, theft, or loss for any reason.**
